## National Children's Alliance Accreditation Standards

CAPstone is an accredited member of the National Children's Alliance. In 2015 we will be up for reaccreditation. Each newsletter will feature one of the ten accreditation standards in order to promote learning and to inform you of what your Child Advocacy Center is doing to meet them.

## **Case Tracking Standard**

Children's Advocacy Centers must develop and implement a system for monitoring case progress and tracking case outcomes for all MDT components.

## **Essential Components:**

The CAC's written documents include tracking case information until final disposition.

CAPstone is meeting this component by tracking all case information on NCA trak. Information is gathered from CAPstone's intake form, during MDT meetings, through N-Focus, and NDEN. CAPstone works closely with law enforcement, DHHS workers, and the County Attorney's to maintain accurate information regarding the case status until case closure.

The CAC tracks and is minimally able to retrieve NCA statistical information.

CAPstone is meeting this component by documenting all information on NCA trak. CAPstone tracks demographic information for child victims, family members and alleged perpetrators. CAPstone also tracks allegations, whether or not a child disclosed, investigative findings, and court dispositions. We track MDT meetings and document a summary of the case review for each case in NCA trak. CAPstone documents services provided such as drug testing, referrals to counseling and DOVES, and medical examinations. Every advocacy contact with the family is also documented in NCA trak through the life of the case. The information that CAPstone tracks is available to MDT members upon request.
