Capstone opened its doors January 2000, was staffed with a part time director and the center was used only by Law Enforcement and CPS workers. In August. 2004 a new full time director was hired. #### Accreditation Standard 1

Standard 1: Child-appropriate/ child friendly facility: a CAC provides a comfortable, private, child friendly setting that is both physically and psychologically safe for diverse populations of children and their families.

Provide a description of your CAC, detailing how the facility meets the child-appropriate/child friendly facility standard. You should provide a separate answer for each of the standard's criteria and clearly label each.

Criterion A: The Child Advocacy Center (CAC) is designed to provide complete separation of victims and alleged offenders to the maximum extent possible.

Criterion B: Facility allows for interviews to be observed by team members while interview is taking place.

Criterion C: CAC is maintained in a manner, which is physically safe

a manner, which is physically safe and "child-proof" for children of all ages.

Criterion D: Children and families can be observed or supervised by staff/ volunteers/team members at all times.

Criterion E: Separate and private areas are available for case consultation and discussion, meetings with family members, and waiting areas.

Criterion F: CAC provides access to materials and toys that reflect the needs and interests of the diverse population of children served.

Criterion G: The CAC setting reflects the social, cultural, and ethnic make up of the community served.

Criterion H: The location of the CAC is convenient to clients and team members to the maximum extent possible.

Criterion I: The CAC makes reasonable accommodations to make the facility physically accessible for children and their families.
