## Vicky Moreno, Investigator - Scottsbluff County Attorney

Vicky Moreno is a special investigator for the Scotts Bluff County Attorney's Office, and has been in that capacity since 1984. Prior to that she was with the Scotts Bluff County Sheriff's Office for seven years, and was a dispatcher, the county's first female correction officer, deputy sheriff and investigator. Vicky has a B.A. degree in Criminal Justice from Chadron State College, graduated from the Nebraska Law Enforcement Training Center as president of her class, and is a trained forensic interviewer, along with having attended over 100 other schools and seminars involving interrogation, crime scene investigation, drunk driving, etc.

Vicky has received the James Herbert Spears Pursuit of Justice award and the Soroptimists' Women Helping Women award for her work involving child abuse and domestic violence.

She has served on various boards including DOVES; the National District Attorney Investigator's Association; the governor's task force on the treatment of sex offenders; the governor's task force of child abuse; and is a founding member of CAPstone and is currently the Secretary of the board.

Vicky is very happy with the way interviewing children has progressed from her having to interview them using kerosene lanterns to now having taped interviews since the discovery of electricity.
